State Road (SR) 80/Southern Boulevard at Forest Hill Boulevard Intersection Improvements Project Palm Beach County, FL Financial Project ID: 436307-1-52-01

SR 80/SOUTHERN BOULEVARD AT FOREST HILL BOULEVARD INTERSECTION IMPROVEMENTS

This 0.46-mile intersection improvement project, located in Royal Palm Beach and Wellington, consists of adding a third westbound to southbound left-turn lane from SR 80 to Forest Hill Boulevard, widening the bridge over the C-51 Canal, converting the Forest Hill Boulevard northbound right-turn lanes to a free-flowing right-turn lane, and widening Southern Boulevard to accommodate an eastbound acceleration lane. Other improvements include milling and resurfacing, drainage, curb and gutter, lighting, guardrails, signalization, sidewalks, landscaping, signage and pavement markings.

PROJECT ACTIVITIES

Please see below anticipated work (weather permitting) through Feb. 8:

- Widening along westbound Southern Boulevard
- Installing irrigation and landscaping
- Installing brick pavers and sod in medians
- Pouring concrete for sidewalks
- Milling and resurfacing the roadway
- Installing signage

TRAFFIC IMPACTS

- Lane closures may occur 9 p.m. to 6 a.m. Sunday through Thursday. Daytime lane closures may also occur 9 a.m. to 4 p.m.
- Southern Boulevard's north sidewalk from Crestwood Boulevard to Royal Palm Beach Boulevard is closed. Pedestrians should follow designated detours.


