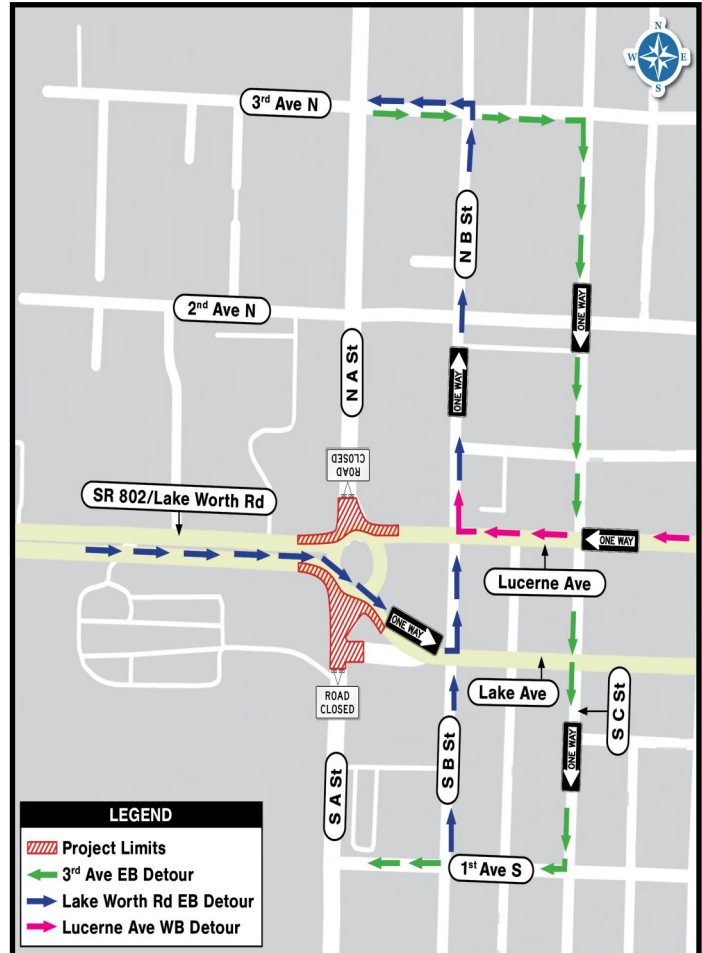
Outside Lane Closure of the SR 802/Lake Worth Road Roundabout for Paving Work, May 8 & May 9, 2024

ROAD CONSTRUCTION WORK ON SR 802/LAKE WORTH ROAD ROUNDABOUT

The outside lane of the SR 802/Lake Worth Road Roundabout will be closed nightly from 8 p.m. until 6 a.m., Wednesday, May 8 and Thursday, May 9 for paving operations.

- Eastbound traffic needing to access northbound N A Street will be detoured around the circle, making a left turn onto S B Street, then a left turn onto 3rd Avenue North.
- Eastbound traffic needing to access southbound S A Street will be detoured around the circle, making a right turn onto S C Street, then a right turn onto 1st Avenue South.
- Southbound traffic on N A Street accessing Lake Worth Road/Lucerne Ave will be detoured eastbound on 3rd Avenue N, then right on N C Street.
- Northbound traffic on S A Street accessing Lake Worth Road/Lake Ave will be detoured eastbound on 1st Avenue South, then left on S B Street.
- Westbound traffic needing to access northbound N A Street will turn right at N B Street, then left on 3rd Avenue North.
- Westbound traffic needing to access southbound S A Street will turn left at N C Street, then left on 1st Ave S.
- Emergency/First Responder access and local access will be maintained and coordinated.



PROJECT IMPROVEMENTS

- Mill and resurface SR 802/Lake Worth Road from Erie Street to A Street/Lucerne Avenue roundabout and Lucerne Avenue to C Street.
- Construct a six-foot wide sidewalk along the east side of Lake Osborne Drive from Griswold Drive to Erie Street.
- Install a raised crosswalk with signalization on Lucerne Avenue just east of South B Street.
- Upgrade pedestrian signals and curb ramps to meet Americans with Disabilities Act (ADA) standards.
- Upgrade lighting along State Road 802/Lake Worth Road.
