SR 794/Yamato Road Resurfacing, Restoration, and Rehabilitation (RRR) Project

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming State Road (SR) 794/Yamato Road RRR Project. This project aims to enhance the safety, resiliency, and longevity of the infrastructure in our communities. Please see below for detailed meeting information.

Construction Cost: \$3.5 Million **Construction Start:** February 2025 **Anticipated Completion:** Early 2026

PROJECT IMPROVEMENTS

- Milling and repaving the existing roadway within the project limits to enhance long-term infrastructure resiliency
- Upgrading curb ramps and replacing sections of the existing sidewalk to enhance pedestrian safety and connectivity
- Replacing traffic signal mast arms at NW 2nd Avenue to improve infrastructure resiliency and enhance motorist safety
- Upgrading roadway lighting and installing new LED countdown pedestrian signals at NW 2nd Avenue and Dixie Highway to enhance visibility and improve pedestrian safety at crosswalks
- Upgrading signage and pavement markings to enhance visibility and motorist safety

TRAFFIC IMPACTS

- Work will occur in phases to minimize impacts to the public
- Day time lane closures are permitted on SR 794/Yamato Road from east of SR 9/I-95 to SR 5/US 1/Federal Highway, as needed, from 9:00 a.m. until 3:00 p.m.
- Nightly Eastbound lane closures are permitted on SR 794/Yamato Road from east of SR 9/I-95 to SR 5/US 1/Federal Highway, as needed, from 9:00 p.m. until 6:00 a.m., Sunday through Thursday
- Nightly Westbound lane closures are permitted:
 - SR 794/Yamato Road from east of SR 9/I-95 to Dixie Highway, as needed, from 9:00 p.m. until 6:00 a.m., Sunday through Thursday
 - SR 794/Yamato Road from Dixie Highway to SR 5/US 1/Federal Highway, as needed, from 6:00 p.m. until 6:00 a.m., Sunday through Thursday
- Access to businesses and residences will be maintained at all times

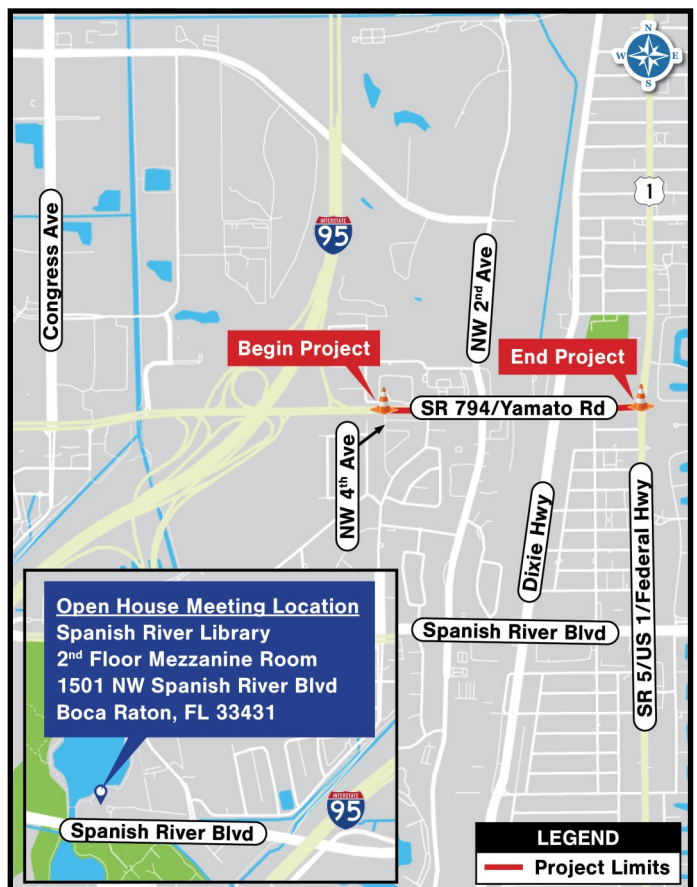
