

## TRAFFIC IMPACTS

- Construction will occur in phases to minimize impacts to the public
- Single lane closures are allowed daily from 8:00 a.m. until 6:00 p.m.; flagging operations will be used to direct traffic
- Full roadway closures will be required at six (6)
  railroad crossings; advanced notice will be provided,
  and motorist and pedestrian detours will be
  clearly marked
- Access to businesses, residences, driveways, and bus stops will be maintained at all times
