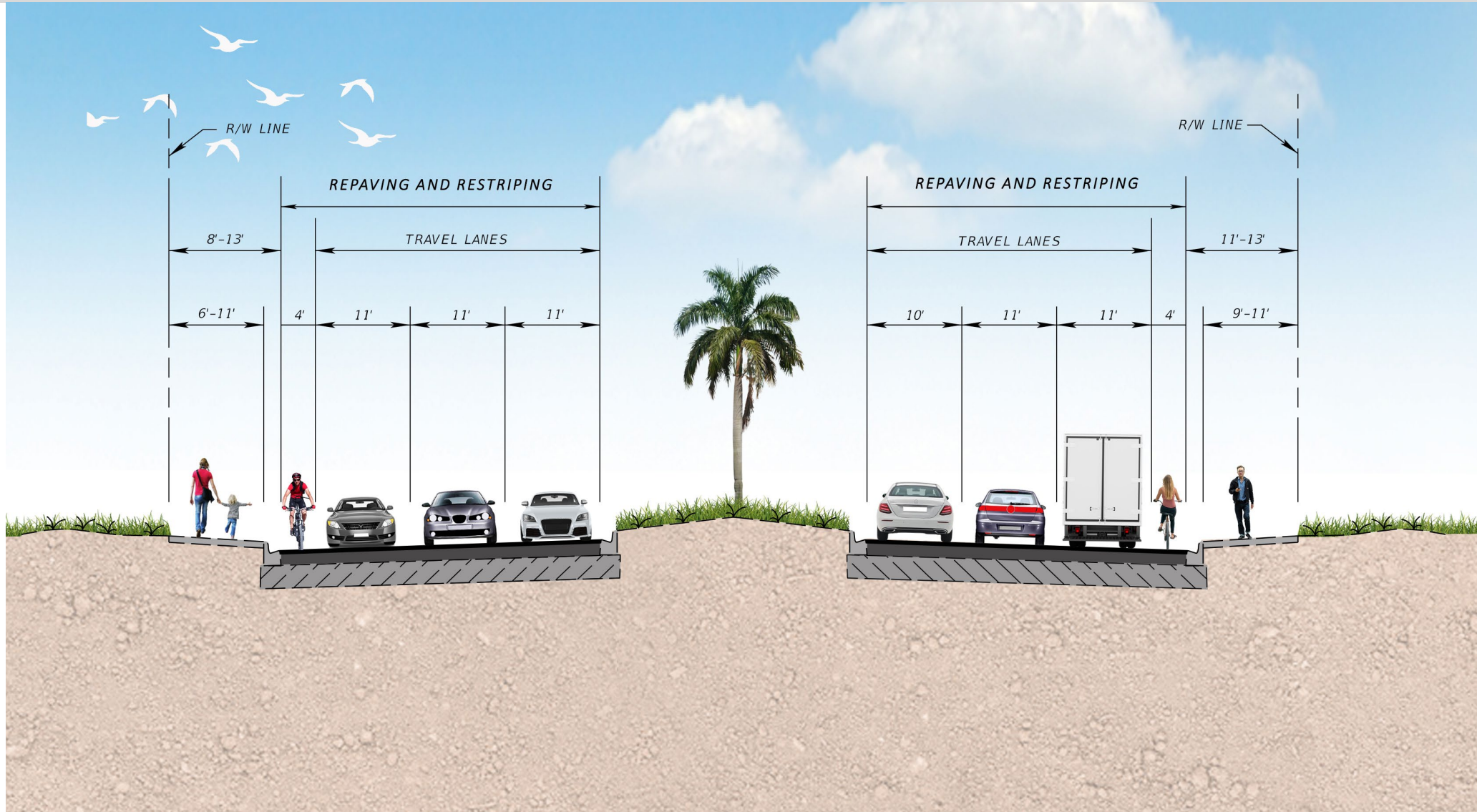

Proposed Improvements

Proposed Improvements

- Repave and restripe the existing roadway within the project limits.
- Upgrade non-compliant Americans with Disabilities Act (ADA) curb ramps along the existing sidewalk.
- Replace the traffic signal mast arms at NW 2nd Avenue.
- Upgrade roadway lighting to illuminate pedestrian crosswalks at NW 2nd Avenue and N. Dixie Highway.
- Upgrade pedestrian signal heads with new LED countdown signals at NW 2nd Avenue and N. Dixie Highway.
- Upgrade signage and pavement markings.

Project Length: 0.633 miles

Lighting and Signalization Improvements



Lighting retrofits at existing signalized intersections to improve visibility.



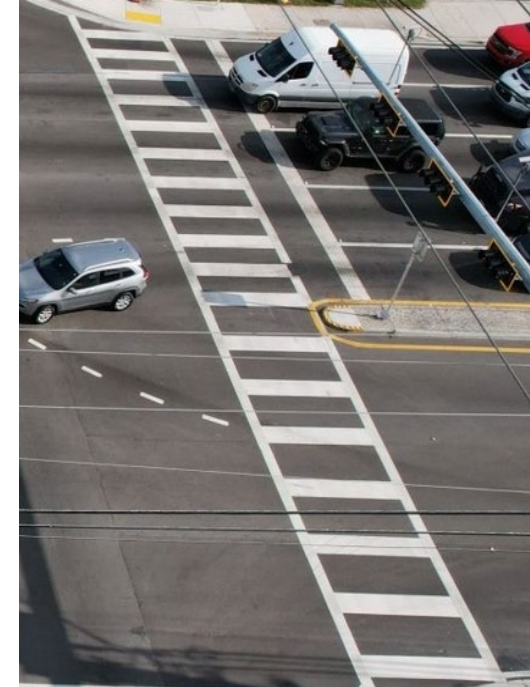
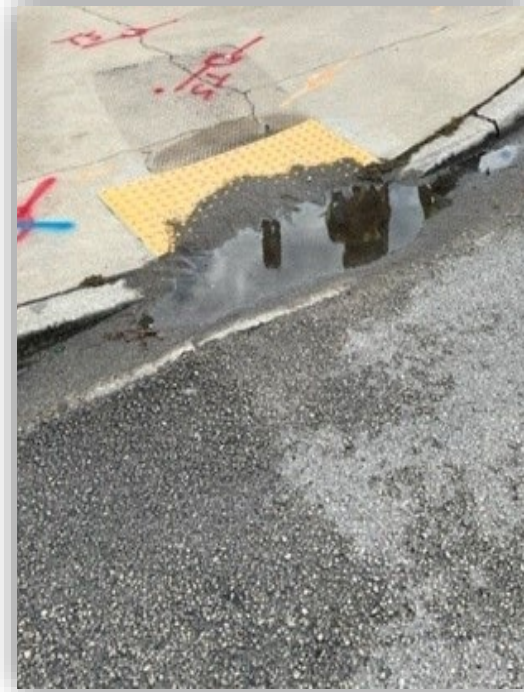
Replacement of pedestrian push-buttons and signal heads to meet Americans with Disabilities Act (ADA).

Upgrade Traffic Signal System at Yamato Rd and NW 2nd Avenue



Existing mast arms will be replaced at all 4 corners on NW 2nd Avenue. Traffic and pedestrian features will also be upgraded.

Americans with Disabilities Act Curb Ramps



- Non-compliant curb ramps will be upgraded along the existing sidewalk.
- High emphasis pedestrian crosswalks will be added to all signalized intersections.

Installation of Green-Colored Bicycle Lanes (5-feet)

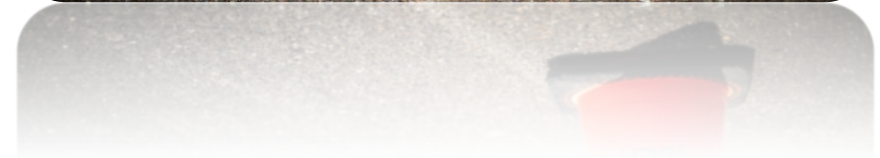
Green-colored pavement will be installed at conflict points to increase driver awareness.



Construction Impacts

Construction Impacts

- Work will be done in phases to reduce the effects of construction to the community
- Temporary lane closures to build the improvements will be completed during non-peak hours
- Night work will be allowed
- Pedestrian traffic will be maintained at all times
- Access to properties adjacent to the corridor will be maintained during construction

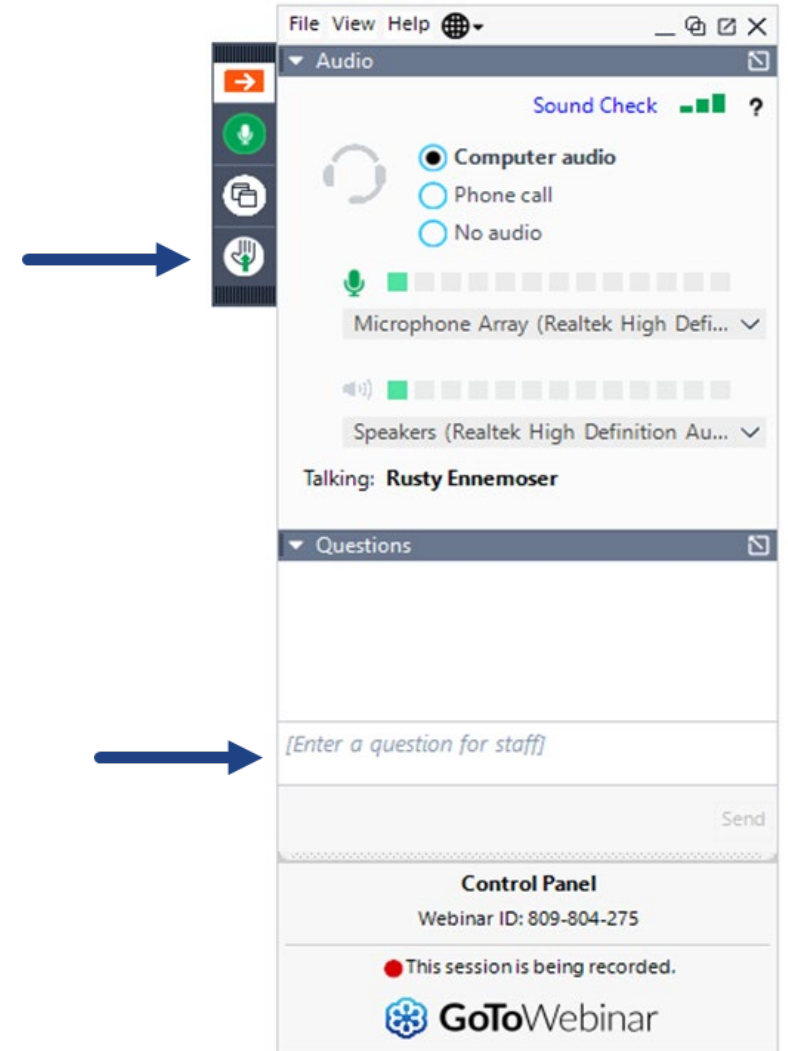
- ❑ Estimated Construction Start: Fall 2024

- ❑ Estimated Construction Cost: \$2.6 million



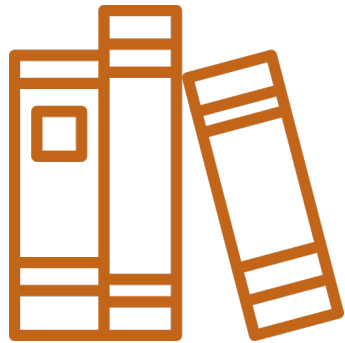
