SR 710/SW WARFIELD BOULEVARD AT SW TOMMY CLEMENTS STREET

The Florida Department of Transportation (FDOT) is pleased to share information regarding the upcoming SR 710/SW Warfield Boulevard at SW Tommy Clements Street in the Village of Indiantown. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. Please see below for project information.

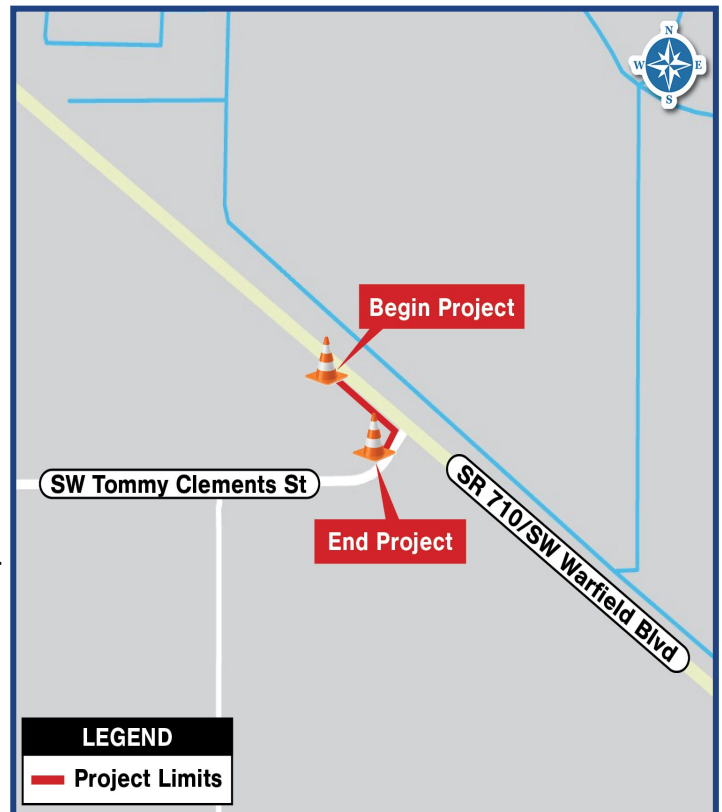
Construction Cost: \$878,088.56 **Construction Start:** September 22, 2025 **Estimated Completion:** Spring 2026

PROJECT IMPROVEMENTS

- Constructing a new eastbound right turn lane on SR 710/SW Warfield Boulevard at SW Tommy Clements Street to enhance safety and traffic operations.
- Milling and repaving the roadway within the project limits to ensure long-term resilience.
- Upgrading the pavement markings to enhance safety, functionality, and traffic operations.
- Replacing the existing guardrail to enhance motorist safety.

TRAFFIC IMPACTS

- Single-lane closures on SR 710/Southwest Warfield Boulevard are permitted as follows:
 - Daily, as needed, from at 9:00 a.m. to 4:00 p.m.
 - Nightly, as needed, from at 6:00 p.m. to 7:00 a.m.
- The speed limit on SR 710/Southwest Warfield Boulevard within the construction zone will be reduced from 60 MPH to 50 MPH during construction.
- Business, pedestrian and residential access will be maintained at all times throughout construction.
