SUN Trail Improvements Project

In partnership with the Florida Department of Environmental Protection, City of Fort Pierce, St. Lucie County, and the St. Lucie County Transportation Planning Organization, the Florida Department of Transportation (FDOT) is pleased to assist with the construction of the newest segment of the Shared-Use Nonmotorized (SUN) Trail Network which will be located within the Savannas Preserve State Park. PROJECT IMPROVEMENTS

This segment of the Shared-Use Nonmotorized (SUN)
 Trail Network will be located within the Savannas

Preserve State Park. The SUN Trail project improvements consist of constructing approximately 4.2 miles of 10-foot wide (8-feet where constrained) accessible multi-use trail.
