95 Express Lanes Phase 3C - Full Closure Notice

State Road (SR) 9/I-95 from south of SR 820/Hollywood Boulevard to south of SR 842/Broward Boulevard and SR 862/I-595 from US 441/SR 7 to SR 9/I-95

EASTBOUND SR 862/I-595 BETWEEN SR 84 & POND APPLE SLOUGH BRIDGE TO CLOSE OVERNIGHT, SEPT. 30

All lanes of eastbound SR 862/I-595 between SR 84 and Pond Apple Slough bridge will be closed to traffic from 10 p.m. until 4 a.m. on Tuesday, Sept. 30 for overhead sign structure installation. The first lane will close at 9 p.m., the second lane will close at 9:30 p.m., and all lanes will be closed by 10 p.m., reopening by 4 a.m. Traffic will be detoured via the SR 862/I-595 eastbound exit ramp (Exit 8 / 9A-B) to southbound SR 7/US 441, eastbound SR 818/Griffin Road, and northbound SR 9/I-95 to access the SR 862/I-595 eastbound entrance ramp.

To ensure community and public safety, the following ramps will also be closed nightly from 10 p.m. until 4 a.m., Tuesday, Sept. 30:

- The eastbound SR 862/I-595 entrance ramp from northbound SR 7/US 441
- The eastbound SR 862/I-595 entrance ramp from southbound SR 7/US 441 and SR 91/Florida's Turnpike
- The eastbound SR 862/I-595 entrance ramp from SR 91/Florida's Turnpike and eastbound SR 84

Wednesday, Oct. 1 and Thursday, Oct. 2 will be used as contingency nights if needed.

The **Florida Highway Patrol (FHP)** will be on site to assist with traffic control, and detour signage will be in place to guide motorists safely through the area. For additional project specific information, please visit https://tinyurl.com/i95ExpressPhase3C.
