### SR A1A/South Ocean Boulevard Drainage Improvements Project

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming SR A1A/South Ocean Boulevard Drainage Improvements Project. FDOT is constructing this project in partnership with Broward County (Resolution No. 23-2271) and the City of Hollywood (Resolution No. R-2024-095). This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. The project limits are on SR A1A/South Ocean Boulevard from Sherman Street to SR 822/Sheridan Street, from Franklin Street to Walnut Street, and from Crocus Terrace to Van Buren Street in the City of Hollywood. **Construction Cost:** \$34.3 Million

**Construction Start:** June 2025

**Estimated Completion:** Summer 2028

#### PROJECT IMPROVEMENTS

- Installing four stormwater pump stations and drainage structures near the intersections of SR A1A/ South Ocean Boulevard and Azalea Terrace, Van Buren Street, Sherman Street, and Franklin Street to enhance long-term infrastructure resilience
- Installing a seawall along SR A1A/South Ocean Boulevard from Sherman Street to SR 822/Sheridan Street, and from Palm Street to Walnut Street to enhance long-term infrastructure resilience
- Reconstructing sidewalks and the roadway affected by pump station and seawall installation

#### TRAFFIC IMPACTS

- Full closures of SR A1A/South Ocean Boulevard will be implemented for the major underground infrastructure for the pump stations and drainage crossings of A1A
- Daytime and nighttime work will be performed within the project limits
- Business and residential access will be maintained at all times throughout construction

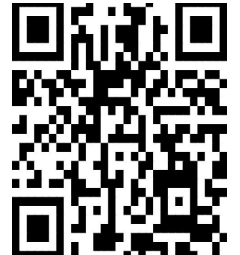

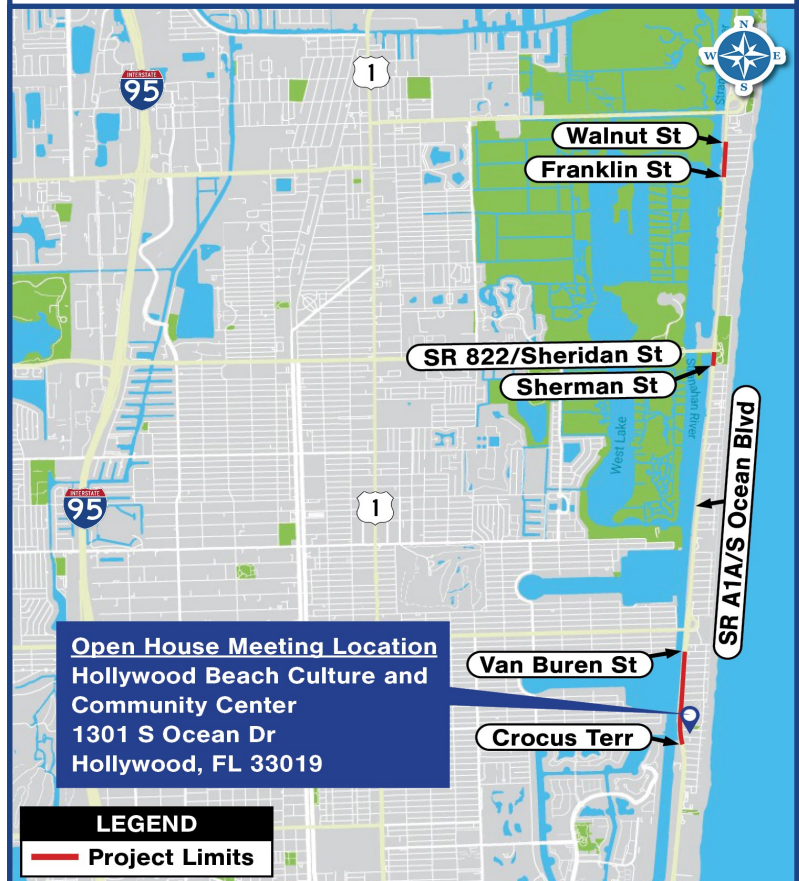
