Southbound NE 4th Avenue at S.R. 838/Sunrise Boulevard will be closed to traffic overnight, from 9 p.m. until 7 a.m., on Wednesday, Jan. 28, 2026, for paving operations. NE 4th Avenue traffic will be detoured via westbound S.R. 838/Sunrise Boulevard, southbound N. Andrews Avenue, eastbound NE 6th Street, and southbound NE 3rd Avenue. Thursday, Jan. 29 and Friday, Jan. 30 will be used as contingency nights if needed. Signage will be in place to assist motorists.
