Southbound NW 7th Avenue at S.R. 838/Sunrise Boulevard to close overnight Tuesday, Jan. 27

Southbound NW 7th Avenue at S.R. 838/Sunrise Boulevard will be closed to traffic overnight, from 9 p.m. until 7 a.m., Tuesday Jan. 27, 2026, for paving operations. NW 7th Avenue traffic will be detoured via westbound S.R. 838/Sunrise Boulevard, southbound S.R. 845/Powerline Road/NW 9th Avenue, eastbound Sistrunk Boulevard/NW 6th Street, and southbound NW 7th Avenue. Wednesday, Jan. 28 and Thursday, Jan. 29 will be used as contingency nights if needed. Signage will be in place to assist motorists.
