Southbound NW 8th Avenue at S.R. 838/Sunrise Boulevard to close overnight Thursday, Jan. 29

Southbound NW 8th Avenue at S.R. 838/Sunrise Boulevard will be closed to traffic overnight, from 9 p.m. until 7 a.m., Thursday, Jan. 29, 2026, for paving operations. Motorists traveling westbound S.R. 838/Sunrise Boulevard will be detoured via southbound S.R. 845/Powerline Road/NW 9th Avenue, eastbound Sistrunk Boulevard/NW 6th Street, and southbound NW 8th Avenue. Motorists traveling eastbound S.R. 838/Sunrise Boulevard will be detoured via southbound N. Andrews Avenue, westbound Sistrunk Boulevard/NW 6th Street, and southbound NW 8th Avenue. Friday, Jan. 30 and Monday, Feb. 2 will be used as contingency nights if needed. Signage will be in place to assist motorists.
