Northbound NW 7th Avenue at S.R. 838/Sunrise Boulevard to close overnight Sunday, Jan. 25

Northbound NW 7th Avenue at S.R. 838/Sunrise Boulevard will be closed to traffic overnight, from 9 p.m. until 7 a.m., Sunday Jan. 25, 2026, for paving operations. NW 7th Avenue traffic will be detoured via westbound S.R. 838/Sunrise Boulevard, northbound S.R. 845/Powerline Road, eastbound 13th Street, and northbound NW 7th Avenue. Monday, Jan. 26 and Tuesday, Jan. 27 will be used as contingency nights if needed. Signage will be in place to assist motorists.
