

## SR 834/SAMPLE ROAD EASTBOUND AT SR/I-95 TO CLOSE NIGHTLY MARCH 18 & 19

All lanes of SR 834/Sample Road eastbound at SR 9/I-95 will be closed to traffic nightly, 11 p.m. until 5 a.m., Monday night, March 18 and Tuesday night, March 19 for bridge coating operations. The first lane will close at 10 p.m., the second lane will close at 10:30 p.m., and all lanes will be closed at 11 p.m., reopening by 5 a.m. In association with this operation, the SR 9/I-95 northbound entrance ramp from eastbound SR 834/Sample Road and the SR 9/I-95 southbound entrance ramp from westbound SR 834/Sample Road will also closed. Eastbound SR 834/Sample Road traffic will be detoured via SR 9/I-95 southbound, Copans Road, and SR 9/I-95 northbound. Signage will be in place to assist motorists. Monday, March 25 and Tuesday, March 26 will be used as contingency if needed.



Improvements as part of this project include constructing dedicated merge lanes for SR 9/I-95 northbound and southbound traffic from SR 834/Sample Road that are physically separated from the SR 9/I-95 general purpose lanes, constructing noise walls, installing signalization mast arms on SR 834/Sample Road at the SR 9/I-95 northbound and southbound off ramps and at the NE 3rd Avenue intersection, updating the lighting and the intelligent transportation systems (ITS) at the SR 9/I-95 and SR 834/Sample Road interchange, roadway and bridge widening, milling and resurfacing, signing and pavement markings, and widening and milling and resurfacing on NE 3rd Avenue from south of NE 35th Court to south of NE 38th Street.
