The City of Weston and the City of Sunrise, as the Project Sponsors, requested through the Broward Metropolitan Planning Organization (MPO) that FDOT, District Four, design and construct the Weston Road Mobility Improvements Project through the City of Weston Resolution 2016-06 and the City of Sunrise Resolution 16-2. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access throughout the Broward region. PROJECT IMPROVEMENTS

- Widening the roadway to accommodate designated bicycle lanes
- Modifying and relocating drainage structures, and regrading swale areas impacted by roadway widening
- Upgrading pedestrian signals at the following intersections:
 - Indian Trace
 - Saddle Club Road/North New River Circle
 - Hampton Lakes/Blatt Boulevard
- Repaving and upgrading pavement markings along Weston Road from Indian Trace to SR 84

TRAFFIC IMPACTS

- Lane closures are permitted nightly, 8:30 p.m. until 7 a.m. Sunday through Thursday
- Pedestrian detours will be in place during sidewalk closures, as needed
- Business and residential access will be maintained at all times throughout construction
- Additional information about lane closures and detour information will be provided in the weekly traffic impacts report distributed by FDOT
