PROPOSED IMPROVEMENTS

- Repaving and restriping the existing roadway
- Upgrading the existing sidewalk to current Americans with Disabilities Act (ADA) standards
- Replacement of deficient signing and installation of new pavement markings
- Upgrading the pedestrian crosswalks at signalized intersections to countdown timers. The existing signalized intersections are as follows:
 - NW 30 Place
 - W Sample Road
 - NW 40 Court
 - NW 48 Street/Wiles Road/Green Road
 - SW 15 Street

CONSTRUCTION IMPACTS

- Work will be scheduled in phases to reduce effects of construction on the community
- Temporary lane closures will take place during non-peak hours to reduce impact to the public
- Access to businesses and private properties will be maintained at all times during construction

- Construction Start Date: **Winter 2022/2023**
- Anticipated Completion: **Spring 2024**
- Construction Cost Estimate: **\$3.6 Million**

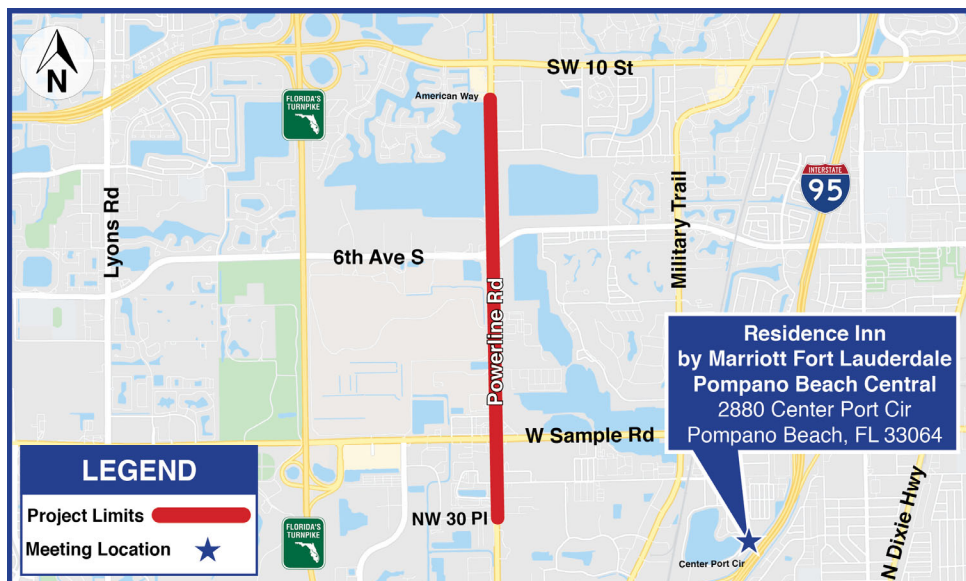
