Dykes Road Mobility Improvements Project

The Florida Department of Transportation (FDOT), will host a Virtual Public Meeting and in-person Construction Open House regarding the upcoming mobility improvements along Dykes Road in the Cities of Miramar and Pembroke Pines and along NW 196th Avenue in the City of Pembroke Pines. Please see below for detailed meeting information.

The Cities of Miramar and Pembroke Pines, as the Project Sponsors, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT District Four design and construct the Dykes Road Mobility Improvements Project through the City of Miramar's Resolution No. 19-117 and the City of Pembroke Pine's Resolution No. 3774. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally-mandated agency responsible for setting policy on local transportation issues and decides how to spend federal and state funding on transportation projects in the Broward region. Construction Cost: \$6,578,249

Construction Start: mid-July 2022

Estimated Completion: Fall 2023

PROJECT IMPROVEMENTS

- Widening the roadway along Dykes Road and NW 196th Avenue to accommodate 6-foot bicycle lanes in each direction
- Extending the right-turn lane to connect to southbound I-75 along eastbound Miramar Parkway
- Upgrading pedestrian signalization at the intersections of:
 - Dykes Road and Miramar Parkway
 - Dykes Road and SR 820/Pines Boulevard
 - NW 196th Avenue and SR 820/Pines Boulevard
 - NW 196th Avenue and SR 822/Sheridan Street
- Installing rectangular rapid flashing beacons (RRFB) at the intersection of NW 10th Street and NW 129th Avenue
- Milling, resurfacing, and upgrading signing and pavement markings throughout the project limits

TRAFFIC IMPACTS

- Lane closures are permitted along Dykes Road and NW 196th Street, weekdays and weekends, between 7 a.m. and 6 p.m., and overnight between 9 p.m. and 6 a.m.
- Business, residential, and pedestrian access will be maintained at all times.
