

- SAVE LIVES, avoid distractions and always drive sober.



Pedestrian improvements in the Lakeside neighborhood that consists of adding 5-foot concrete sidewalks at various gap locations at the following locations:


- NW 24th Avenue from NW 27th Street to Dead End
- NW 29th Street/NW 22nd Terrace from NW 24th Avenue to NW 28th Street
- NW 27th Street (West) from NW 24th Avenue to NW 21st Avenue
- NW 27th Street (East) from NW 21st Avenue to Dead End
- NW 28th Street (East) from NW 21st Avenue to NW 18th Terrace
- NW 18th Terrace Dead End to NW 28th Street
- NW 19th Avenue Dead End to NW 27th Street
- NW 20th Street
































6. Maintenance of Traffic



Maintenance of Traffic

- The existing number of travel lanes shall be maintained at peak traffic periods during construction.
- Construction personnel will coordinate with residences if any temporary driveway closures are needed.
- Access to schools, businesses and residences will be maintained at all times.
- No driveways will be closed or relocated as part of this project.




