




Existing Roadway

- Mill existing pavement and resurface with new asphalt
- Drainage improvements at driveways
- Upgrade existing crosswalks, curb ramps, detectable warning surfaces, pedestrian signals, and sidewalks to meet ADA (Americans Disabilities Act) standards.
- Add special emphasis crosswalks on all signalized intersections
- Upgrade all lighting to LED fixtures to meet roadway and signalization illumination criteria
- Replace traffic monitoring site along the corridor
- Restriping pavement by reducing existing lane widths while increasing bicycle lane widths to better accommodate bicyclist
- Removal of abandoned driveways
- Install a "Next Signal University Drive" sign for westbound traffic approach to the intersection
- Upgrade signalization at NW 85 Ave, Riverside Dr, and Holiday Springs Blvd



- Add special emphasis crosswalks on all signalized intersections
- Upgrade all lighting to LED fixtures to meet signalization illumination criteria
- Restriping pavement by reducing existing lane widths while increasing bicycle lane widths to better accommodate bicyclist
- Removal of abandoned driveway and right turn lanes
- Upgrade signalization at 1800 Block (Costco Entrance)



Maintenance of Traffic

- Work will be done in phases to reduce the effects of construction on the community
- Temporary lane closures will take place during non-peak hours to reduce impact to the traveling public
- Access to businesses and residences will be maintained at all times
- No detours are necessary. Lane closures will be limited to one travel lane at a time




