# LIGHTING IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT), District Four, is pleased to provide information regarding lighting improvements along SR 817/University Drive, SR 834/Sample Road, SR 845/Powerline Road and SR 814/Atlantic Boulevard. The improvements will take place in the cites of Coral Springs, Margate, Pompano Beach, Deerfield Beach and Fort Lauderdale in Broward County, Florida.

# **PROJECT IMPROVEMENTS**

- Upgrading existing roadway lighting with new LED fixtures to provide efficient light distribution, save energy and reduce maintenance costs
- New LED lighting will be installed at 10 intersections along University Drive, 12 intersections along Powerline Road, four intersections along Sample Road and 15 intersections along Atlantic Boulevard
- Installation of new light poles will occur at some locations

#### **MAINTENANCE OF TRAFFIC**

- Access to residences and businesses will be maintained at all times.
- Existing speed limits will remain in place.
- University Drive and Powerline Road lane closures may occur:

9:00 a.m. to 3:30 p.m. weekdays and weekends 9:00 p.m. to 5:30 a.m. Sunday through Thursday 11:00 p.m. to 7:00 a.m. Friday and Saturday

• Atlantic Boulevard and Sample Road lane closures may occur 9:00 a.m. to 4:00 p.m.
