The Florida Department of Transportation (FDOT), District Four, will conduct a Virtual Public Meeting regarding the above referenced project within the City of Hollywood in Broward County. This Virtual Public Meeting will have a presentation followed by a question/comment period. Project information will be available for public viewing. PROJECT IMPROVEMENTS

- Resurface US - 1 to provide two traffic lanes and one bicycle lane in each direction
- Install new pedestrian lighting along the corridor
- Upgrade existing lighting to LED
- Replace concrete sidewalk with pavers from Monroe Street to Fillmore Street
- Install stamped asphalt crosswalks at all signalized intersections

CONSTRUCTION IMPACTS

- Work will be completed in phases to minimize construction impacts
- Single lane closures will be required during construction along US - 1 and some of the the side streets
- No full roadway closures will be required
- Lane closures will occur during off peak traffic times
- Access to properties adjacent to the corridor will be maintained throughout construction

CONSTRUCTION INFORMATION

- Construction Begins: **Estimated Summer 2022**
- Anticipated Completion: **Late Winter 2023**
- Construction Cost Estimate: **\$7.7 million**

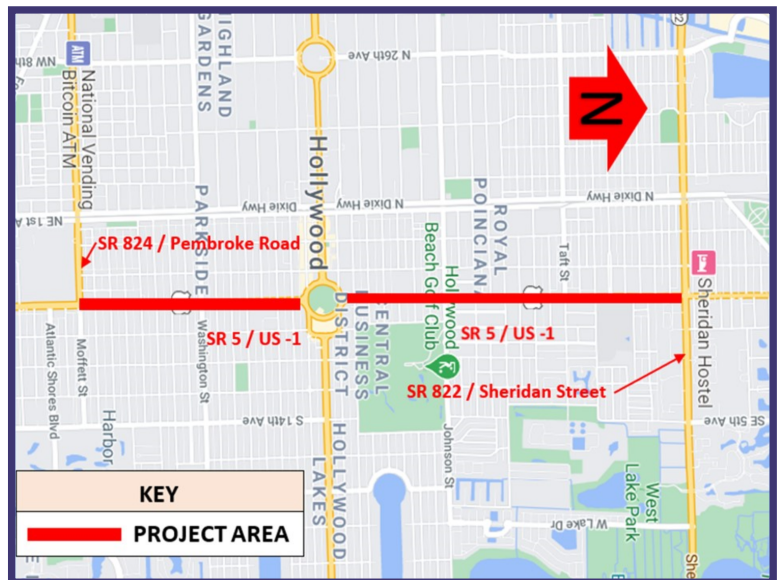
