COPANS ROAD MOBILITY IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming Copans Road Mobility Improvements Project with limits on Copans Road between SR 7/US 441 and NW 49th Terrace in the cities of Coconut Creek and Margate. Please see below for detailed meeting information.

Broward County, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT design and construct the Copans Road Mobility Improvements Project through Broward County Resolution No. 2019-286. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. Construction Cost: \$4,964,677

Construction Start: July 2024

Estimated Completion: Summer 2025

PROJECT IMPROVEMENTS

- Reconstructing the existing roadway and sidewalk to accommodate a 9-foot Shared Used Path along the project limits
- Improving drainage along the project limits
- Upgrading pedestrian signalization on Copans Road at SR 7/US 441 and Banks Road.
- Upgrading curb ramps, signing, and pavement markings along the project limits

TRAFFIC IMPACTS

- Single lane closures are permitted daily and nightly as needed, Monday through Friday.
- Lane closures will not be permitted during the peak hours of 7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 7:00 p.m.
- Business and residential access will be maintained at all times throughout construction.


