The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming lighting improvements along SR 838/Sunrise Boulevard within the cities of Fort Lauderdale and Lauderhill. Construction Cost: \$798,900 Construction Start: July 2023 Estimated Completion: Spring 2024

#### **PROJECT IMPROVEMENTS**

- Upgrading the existing lighting with light-emitting diode
   (LED) luminaires within project limits
- Installing new light posts to enhance roadway illumination within project limits

#### TRAFFIC IMPACTS

- Lane closures along SR 838/Sunrise Boulevard are permitted daily, 10 a.m. until 3 p.m., Monday through Thursday and nightly, 7 p.m. until 7 a.m., Sunday through Thursday.
- Motorist and pedestrian access to businesses and residences will be maintained at all times.


