### STATE ROAD (SR) 9/I-95 MOBILITY HUB AT CYPRESS CREEK ROAD IMPROVEMENTS PROJECT

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the upcoming SR 9/I-95 Mobility Hub at Cypress Creek Road Improvements project. The improvements create efficient transportation connections within the Mobility Hub area including to the Tri-Rail Station, Tri-Rail shuttles, the Park and Ride Lot, Broward County Transit buses, and pedestrian and bicycle facilities. The City of Fort Lauderdale and Broward County as the project sponsors, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT design and construct the SR 9/ I-95 Mobility Hub at Cypress Creek Road Improvements Project through the City of Fort Lauderdale’s Resolution No. 18-137/ Resolution No. 22-66, and Broward County’s Resolution No. 2018-421. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County, and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. #### PROJECT IMPROVEMENTS

- Milling and resurfacing the roadway within project limits
- Modifying the median on Cypress Creek Road
- Adding a 10-foot Shared Use Path (SUP) along Cypress Creek Road
- Constructing new sidewalks along the northside of NW 59th Court and in each direction of N Andrews Way
- Upgrading existing lighting to LED fixtures within project limits
- Installing new mast arms at the intersection of Cypress Creek Road and SR 845/Powerline Road
- Upgrading pedestrian signals at all signalized intersections within project limits
- Upgrading signage and pavement markings
- Installing new landscape within project limits

#### TRAFFIC IMPACTS

- Lane closures are permitted daily 8:30 a.m. until 4:30 p.m., Monday through Saturday, and nightly, 9:00 p.m. until 5:30 a.m., Sunday through Thursday.
- Cypress Creek Road, from SR 845/Powerline Road to the South Florida Rail Crossing, will be reduced to three lanes in each direction for median modification work and drainage.
- NW 59th Court is permitted to close one direction as needed for drainage and paving operations.
  - Westbound NW 59th Court will be detoured via Cypress Creek Road, SR 845/Powerline Road and NW 6th Way.
  - Eastbound NW 59th Court will be detoured via SR 845/ Powerline Road, Cypress Creek Road and NW 6th Way.
- Motorist and pedestrian access to businesses and residences will be maintained at all times.
