The Florida Department of Transportation (FDOT) District Four, will conduct a Construction Open House regarding the improvements along 14th Avenue in the cities of Hallandale Beach, Hollywood, and Dania Beach. Representatives from the FDOT and project partners will be available to answer your questions. This meeting will have an informal open house format; no formal presentation will be made. Construction plans will be available for public viewing.

The Broward Metropolitan Planning Organization (MPO) is investing over \$300 million to create safer, healthier communities in Broward County. This project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally-mandated agency that is responsible for making decisions on local transportation issues and prioritizing how to spend federal funds on transportation projects. 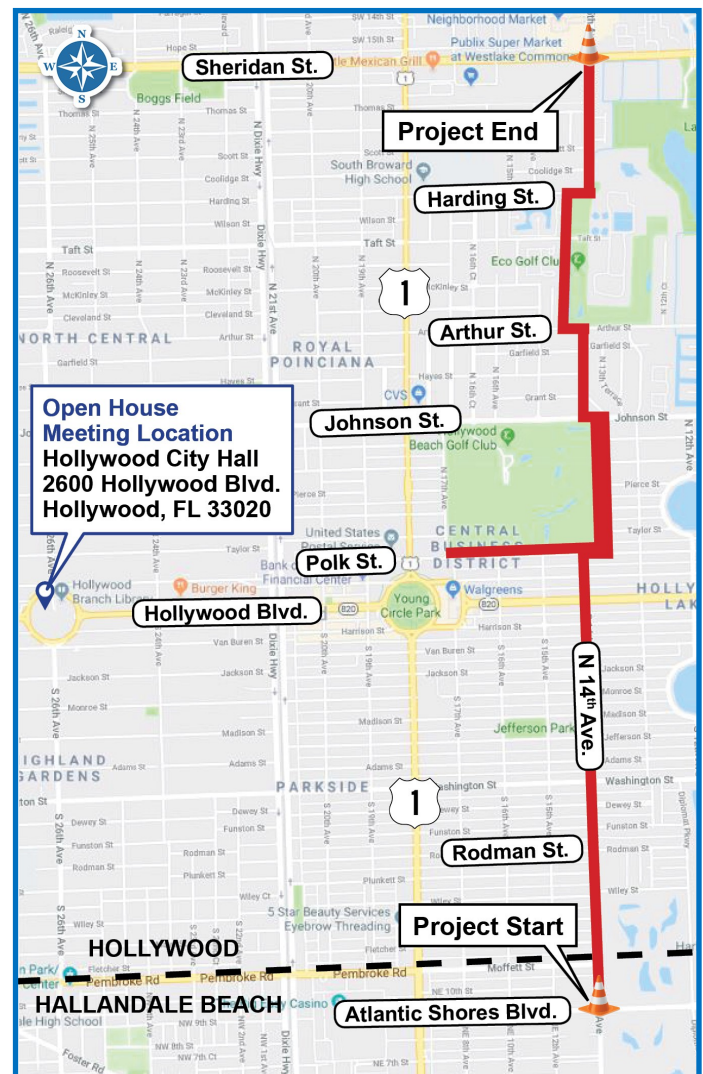

PROJECT IMPROVEMENTS

- Widening the roadway to accommodate bike lanes on 14th Avenue, Arthur Street, and Harding Street.
- Adding shared lane pavement markings along 14th Avenue and Harding Street, to enhance the safe travel of bicycles and motor vehicles in the same traffic lane.
- Installing a shared-use path (off-road path) on Polk Street and 14th Avenue.

TRAFFIC IMPACTS

- Lane closures will occur overnight, Sunday through Thursday between 7 p.m. and 6 a.m., and Friday through Saturday between 7 p.m. and 7 a.m., only one direction at a time. Flagging operations may be needed during these closures.
- Additional lane closure and detour information will be provided in the weekly traffic report distributed by FDOT.
