## SW 64<sup>th</sup> Avenue Mobility Improvements Project

The Florida Department of Transportation (FDOT), District Four, will host a Virtual Public Meeting and in-person Construction Open House regarding the upcoming roadway improvements along SW 64<sup>th</sup> Avenue in the City of Miramar. Please see below for detailed meeting information.

The City of Miramar, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT District Four design and construct the SW 64<sup>th</sup> Avenue Mobility Improvements Project through the City of Miramar Resolution No. 16-01. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally-mandated agency responsible for setting policy on local transportation issues and decided how to spend federal and state funding on transportation projects in the Broward region. **Construction Cost:** \$2.3 million    **Construction Start:** early-September 2022    **Estimated Completion:** Spring 2023

### PROJECT IMPROVEMENTS

- Constructing new sidewalks along southbound SW 64<sup>th</sup> Avenue from SW 35<sup>th</sup> Street to SR-824/Pembroke Road
- Replacing existing 4-foot sidewalk with an 8-foot sidewalk along northbound SW 64<sup>th</sup> Avenue from SR -858/Miramar Parkway to SR-824/Pembroke Road
- Relocating and installing signage
- Relocating impacted drainage structures
- Regrading swales to ensure proper drainage flow
- Milling and resurfacing along the project limits

### TRAFFIC IMPACTS

- Lane closures are permitted from 9 a.m. to 5 p.m., Monday through Friday.
- One direction of SW 64<sup>th</sup> Avenue may have a full closure, weekdays between 9 a.m. to 5 p.m. Traffic will be detoured using SR 7/US 441.
- Business, pedestrian, and residential access will be maintained at all times.
