PROJECT IMPROVEMENTS

- Installing new light poles and upgrading existing lighting with LED fixtures within the project limits

- Lane closures are permitted daily between 9 a.m. and 3:30 p.m.
- Lane closures are permitted Monday through Thursday nights, between 9 p.m. and 5:30 a.m.
- Motorist and pedestrian access to businesses and residences will be maintained at all times.

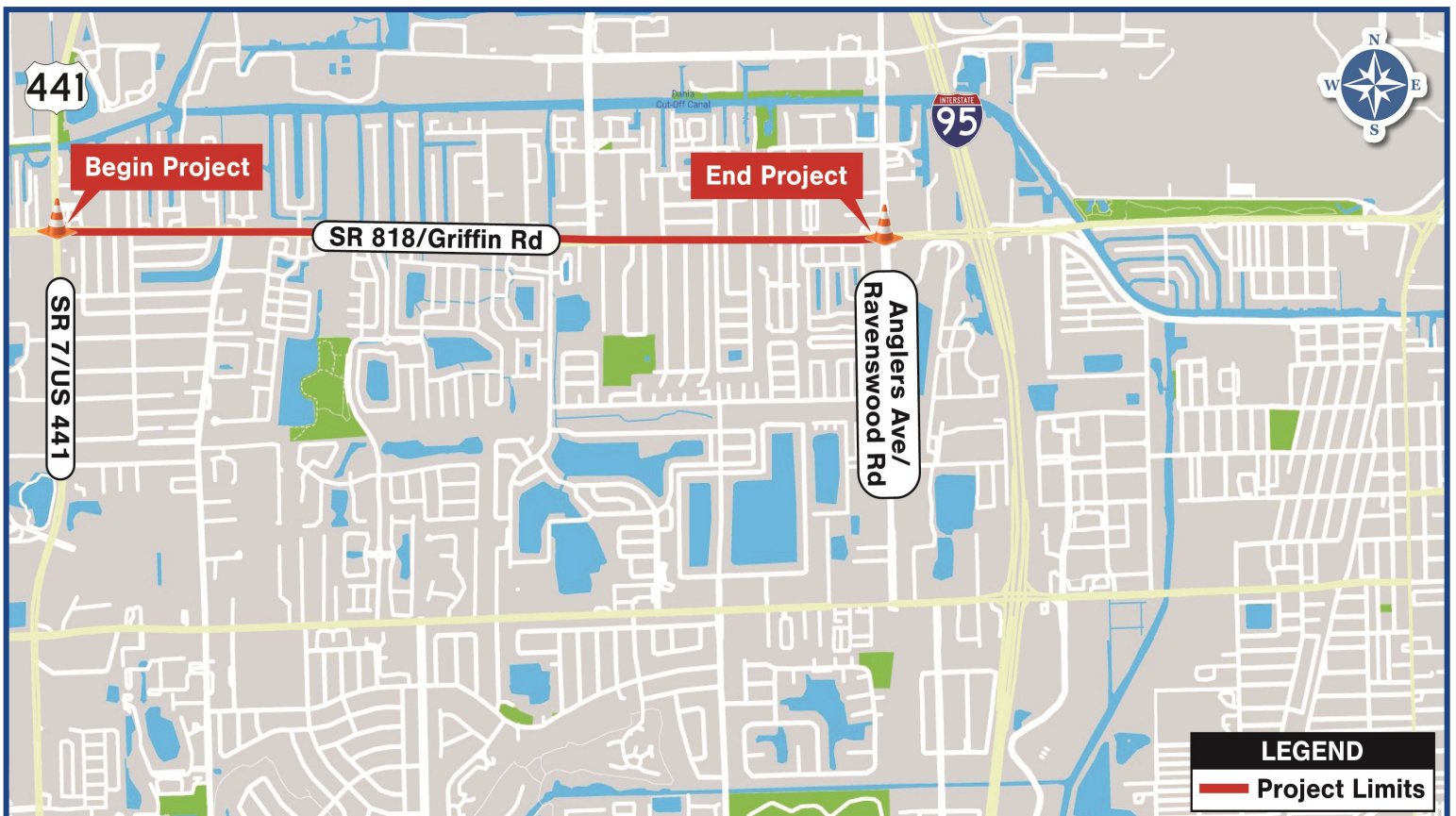
