


# **Existing Conditions**

- SR 93/I-75, Royal Palm Boulevard and Griffin Road are three significant arteries within the cities of Weston, Davie and Southwest Ranches in Broward County, Florida.
- SR 93/I-75 is currently a divided limited access facility with 4 lanes in each direction.
   The I-75 Express Lanes are located within the median of the corridor. The current design and posted speed is 70 mph.



# **Existing Conditions**

SR 93/I-75 runs north and south and provides connectivity to I-595, Homestead Extension of Florida's Turnpike (HEFT), Sawgrass Expressway (SR 869) and the Palmetto Expressway (SR 826)



Existing configuration of southbound off-ramp to westbound Royal Palm Blvd


This construction consists of two projects:

- 1. From the SR 93/I-75 interchange with Griffin Road to south of the Royal Palm Blvd interchange
- From north of Royal Palm Blvd interchange to north of Indian Trace / SW 14 St overpass.

# **Proposed Improvements**

# **Proposed Improvements**


- Widening I-75 mainline for approximately 1 mile along northbound and southbound directions to add auxiliary lanes between Griffin Road and Royal Palm Boulevard interchanges
- Widening of northbound and southbound bridges over C-11 canal
- Milling and resurfacing southbound on-ramp (Ramp A) from Royal Palm Boulevard and modifying existing taper-type entrance to I-75 to a parallel-type entrance
- Widening of northbound off-ramp at Royal Palm Boulevard (Ramp B), northbound on-ramp from Griffin Road (Ramp C1), and southbound off-ramp to Griffin Road westbound (Ramp D) to two lanes.

# **Proposed Improvements**

- Widening southbound off-ramp at Royal Palm Boulevard (Ramp C) to two lanes
- Milling and resurfacing of Royal Palm Boulevard from 600' east of Weston Road intersection to SR 93/I-75 northbound ramps
- Signing, lighting, ITS, and drainage improvements

# **Temporary Traffic Control Plan**

# **Temporary Traffic Control Plan**

- Work will be done in phases to reduce the impacts of construction in the community.
- Roadways will remain open, but lane closures, ramp closures, and detours are anticipated during nonpeak hours to minimize impacts on traffic.
- Access to nearby businesses and residential properties will be maintained at all times during construction.
- Night-time lane closures will be provided for milling and resurfacing and final striping operations near the end of construction.




