### State Road (SR) 7/US 441 Corridor Improvements Project (Group 9)

The Florida Department of Transportation (FDOT) is pleased to provide information regarding the upcoming SR 7/US 441 Transit Corridor Improvements Project (Group 9) along SW 45<sup>th</sup> Street/Orange Drive from Florida's Turnpike to SR 7/US 441; and Taft Street from SR 7/US 441 to N 40<sup>th</sup> Street. Please see below for detailed meeting information.

The Town of Davie and City of Hollywood, as the Project Sponsors, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT District Four design and construct the SR 7/US 441 Transit Corridor Improvement projects along SW 45<sup>th</sup> Street/Orange Drive from Florida's Turnpike to SR 7/US 441 through the Town of Davie Resolution No. 2019-135 and along Taft Street from SR 7/US 441 to N 40<sup>th</sup> Street through the City of Hollywood Resolution No. 2021-280. The Broward MPO is investing over \$300 million to create safer, healthier communities in Broward County and this project is one of many within a larger plan to create enhanced bicycle, pedestrian, and public transportation access. The Broward MPO is a federally mandated agency that is responsible for making decisions on local transportation issues and deciding how to spend federal funds on transportation projects within Broward County. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. ### PROJECT IMPROVEMENTS

#### SW 45<sup>th</sup> Street/Orange Drive from Florida's Turnpike to SR 7/US 441

- Upgrading existing drainage structures to improve long-term resiliency and longevity of critical infrastructure
- Adding a continuous concrete sidewalk along the north side of SW 45<sup>th</sup> Street/Orange Drive to enhance pedestrian mobility
- Upgrading curb ramps, pavement markings, and signage to improve visibility and accessibility

#### Taft Street from SR 7/US 441 to N 40<sup>th</sup> Avenue

- Milling and resurfacing the existing roadway within the project limits to ensure long-term resiliency
- Upgrading existing drainage structures to improve long-term resiliency and longevity of critical infrastructure
- Adding an 8-foot to 11-foot shared-use path along the north side of Taft Street to enhance pedestrian mobility
- Upgrading curb ramps, pavement markings, and signage to improve visibility and accessibility

### TRAFFIC IMPACTS

- Lane closures along SW 45<sup>th</sup> Street/Orange Drive and Taft Street are permitted 9:00 a.m. until 4:00 p.m., Monday through Saturday
- Motorist and pedestrian access to businesses and residences will be maintained at all times
