PURPOSE OF PROJECT: The purpose of the project is to improve safety and serviceability of the multi-use pathway along Canal C-9 and Utopia Drive.

PROPOSED IMPROVEMENTS

Scope of Work for project FM# 445524-1 :

- Reconstructing existing pathway
- Installing guardrail at each intersecting road for increased pedestrian and automobile safety
- Replacing damaged light poles
- Re-furnishing pathway with new benches
- Upgrading signage within project limits

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the impacts to the community
- Temporary lane closures will occur one lane at a time during non-peak hours to minimize impacts on traffic
- Pedestrian traffic will be maintained at all times
- Access to properties along the corridor will be maintained at all times

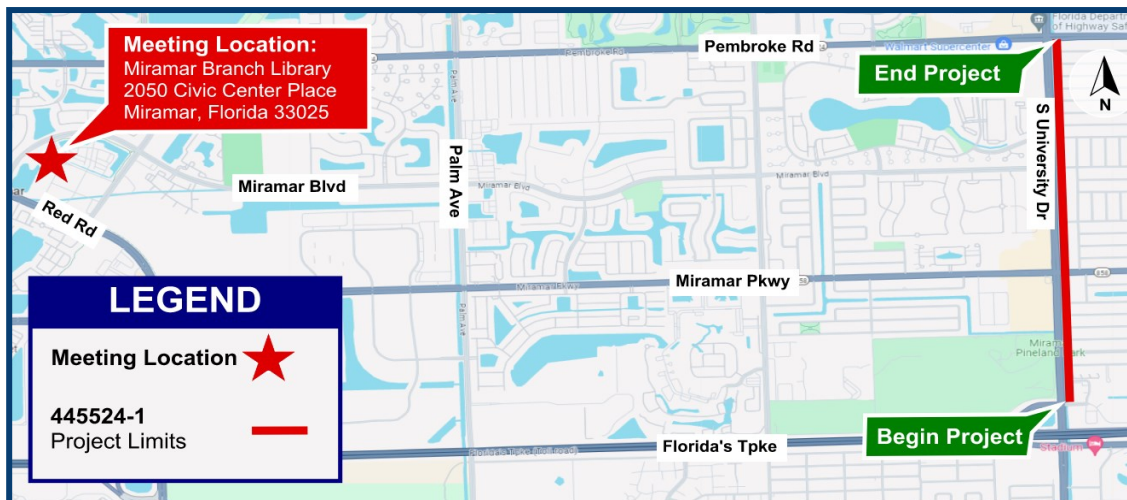
