North 22nd Avenue/SW 12th Avenue
From State Road (SR) 822/Sheridan Street to SR 848/Stirling Road

The Florida Department of Transportation (FDOT) will conduct a public meeting for the above referenced project within Broward County. This public meeting will be offered in-person and virtually simultaneously. The public meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting by contacting the Project Manager. PURPOSE OF PROJECT: This Complete Streets Project will resurface the asphalt pavement and improve bicycle and pedestrian safety throughout the corridor.

PROPOSED IMPROVEMENTS

- Repave and restripe the existing roadway within the project limits
- Install speed tables at various locations along the project corridor
- Install three raised intersections at SW 10th Street, SW 8th Street and SW 7th Street
- Upgrade signing and pavement markings including the addition of shared lane markings (sharrows) which indicate that cyclists should be expected in the lane
- Upgrade existing curb ramps and sidewalks to comply with Americans with Disabilities Act (ADA) standards
- Install roadway lighting along both sides of the roadway

CONSTRUCTION IMPACTS

- Partial side street detours will be required to complete the raised intersections at SW 10th Street, SW 8th Street, and SW 7th Street
- Work will be done in phases to reduce the effects of construction on the community
- Temporary lane closures will be required during construction Lane closures will be performed at off-peak hours
- Access to properties will be maintained during construction

CONSTRUCTION INFORMATION

- Anticipated Construction Start: **Fall 2025**
- Anticipated Construction End: **Winter 2027**
- Estimated Construction Cost: **\$3.5 Million**
