## NW 59<sup>TH</sup> COURT AT NW 6<sup>TH</sup> WAY TO CLOSE SATURDAY, AUG. 24 THROUGH FRIDAY, NOV. 15

NW 59<sup>th</sup> Court at NW 6<sup>th</sup> Way will be closed in each direction nightly, Saturday night, Aug. 24 through Friday night, Nov. 15 for drainage installation. Closures occurring Monday nights through Friday nights will be from 1:30 a.m. until 3:30 a.m., Saturday nights from 10:30 p.m. until 4:30 a.m. and Sunday nights from 10:30 p.m. until 3:30 a.m. Regularly scheduled bus and train routes will be unaffected. Traffic will be detoured via SR 845/Powerline Road, Cypress Creek Road, and NW 6<sup>th</sup> Way. Signage will be in place to assist motorists.



Improvements as part of this project include: milling and resurfacing the roadway within project limits; modifying the median on Cypress Creek road; adding a 10-feet Shared Use Path (SUP) along the project corridor; constructing new sidewalks along the northside of the NW 59 Court and in each direction of N Andrews Way; upgrading existing lighting to LED fixtures within project limits; installing new mast arms at the intersection of Cypress Creek Road and SR 845/Powerline Road; upgrading pedestrian signals at all signalized intersections within the project limits; upgrading signage and pavement markings; installation of new landscape within the project limits.
