LOXAHATCHEE ROAD MOBILITY IMPROVEMENTS PROJECT MONTHLY PROGRESS REPORT- NOVEMBER 2024

The City of Parkland, as the Project Sponsor, received funding through the Broward Metropolitan Planning Organization (MPO) and requested that FDOT design and construct the Loxahatchee Road Mobility Improvements Project through the City of Parkland Resolution Numbers 2016-510, 2021-011, and 2021-018.

The following update provides information on the construction segment of Loxahatchee Road between SR 817/N University **Drive and Parkside Drive, scheduled to reopen by Friday, Dec. 6, 2024.** If weather or unforeseen circumstances arise, Loxahatchee Road will reopen by Friday, Dec. 13, 2024.

COMPLETED CONSTRUCTION ACTIVITIES BETWEEN SR 817/N UNIVERSITY DRIVE AND PARKSIDE DRIVE

- Completed gravity wall installation
- Completed coping (protective cap) installation at sheet pile locations

ANTICIPATED CONSTRUCTION ACTIVITIES BETWEEN SR 817/N UNIVERSITY DRIVE AND PARKSIDE DRIVE

- Continue with the eastbound roadway re-construction west of Parkside Drive
- Continue with curb & gutter and sidewalk installation
- Continue guardrail removal and installation
- FP&L to continue with utility relocation efforts and adjustments

CURRENT MAINTENANCE OF TRAFFIC (MOT)

- To ensure community and crew safety as we work to enhance the roadway and provide a safer and more resilient infrastructure, Loxahatchee Road from SR 817/N University Drive to Parkside Drive is closed through Friday, Dec. 6, 2024. Traffic will be detoured via SR 817/N University Drive, Holmberg Road, and Parkside Drive. Local access will be maintained. Please click this link to view the detour flyer. If weather or unforeseen circumstances arise, Loxahatchee Road will reopen by Friday, Dec. 13, 2024.
- Please note that while the current detour will be lifted, additional lane closures and detours may be implemented as needed for ongoing construction. Every effort will be made to minimize impacts, and all future closures will be communicated well in advance to keep the community informed.
