PROJECT IMPROVEMENTS

- Widening the northbound exit ramp to SR 820/ Hollywood Boulevard to accommodate a designated right-turn lane
- Extending the left-turn lane on SR 820/Hollywood Boulevard to SW 28th Avenue to increase vehicle storage capacity
- Upgrading signalization at the intersection of SR 820/ Hollywood Boulevard and SR 9/I-95
- Upgrading sidewalks and curb ramps to meet Americans with Disabilities Act (ADA) requirements



TRAFFIC IMPACTS

- Single lane closures along SR 820/Hollywood Boulevard and the I-95 northbound exit ramp are permitted between 10:00 p.m. and 7:00 a.m., weekdays and weekends
- Full ramp closure of the I-95 northbound exit ramp are permitted overnight, Sunday through Thursday, between 10:00 p.m. and 6:00 a.m. for asphalt paving operations
