PROPOSED IMPROVEMENTS

- Countdown pedestrian signals at 25 intersections
- New mid-block crossing with mid-block pedestrian signal and street lighting North of Broward Blvd. on SR 7/US 441
- Street lighting retrofits at 22 intersections
- Sidewalk and bike lane improvements along SR 858/ Hallandale Beach Blvd. from West of Edmund Rd. to East of SW 58th Ave. and on SR 7/ US 441 from Southgate Blvd. to the Cypress Creek Greenway/ C-14 Canal

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the effects of construction on the community
- Occasional single lane closure during construction
- Two-way traffic and access to all property will be maintained at all times
