The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming SR 823/Flamingo Road RRR Project from SR 820/Pines Boulevard to SR 824/Pembroke Road in the cities of Pembroke Pines and Miramar. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

Construction Cost: \$3,165,008

Construction Start: January 2025

Estimated Completion: Fall 2025

PROJECT IMPROVEMENTS

- Milling and resurfacing the existing roadway within the project limits to ensure long-term infrastructure resilience
- Constructing a right-turn lane along eastbound SR 824/Pembroke Road to southbound SR 823/Flamingo Road to improve vehicular capacity and mobility
- Replacing the traffic signal mast arm at the northeast corner of SR 824/Pembroke Road and SR 823/Flamingo Road to enhance traffic safety and mobility, and improve signal visibility
- Upgrading existing pedestrian signals at signalized intersections to improve push button accessibility
- Upgrading concrete sidewalks, curb ramps, pavement markings, and signage to improve visibility and accessibility
- Installing new light poles with LED fixtures at the intersections of Washington Street and SR 824/Pembroke Road to improve safety and enhance nighttime visibility

TRAFFIC IMPACTS

- Single lane closures along SR 823/Flamingo Road are permitted as needed daily, 9:00 a.m. until 4:00 p.m., and nightly, 7:00 p.m. until 7:00 a.m.
- Double lane closures along SR 823/Flamingo Road are permitted as needed nightly, 9:00 p.m. until 7:00 a.m.
- Single lane closures along 824/Pembroke Road are permitted as needed daily, 9:00 a.m. until 4:00 p.m.
- Motorist and pedestrian access to businesses and residences will be maintained at all times
