### PROJECT PURPOSE

The purpose of this bridge rehabilitation project is to address independent slab movement between Sonovoid slab units using ultra high-performance concrete joint repair at two (2) bridges within the City of Dania Beach, in Broward County, Florida.

### PROJECT IMPROVEMENTS

- Replace the existing concrete from the longitudinal joints between the slab units with an ultra-high-strength concrete repair.
- Replace the existing bridge deck expansion joint with a newer material.
- Remove and repave the existing asphalt overlay on the bridges.

### CONSTRUCTION IMPACTS

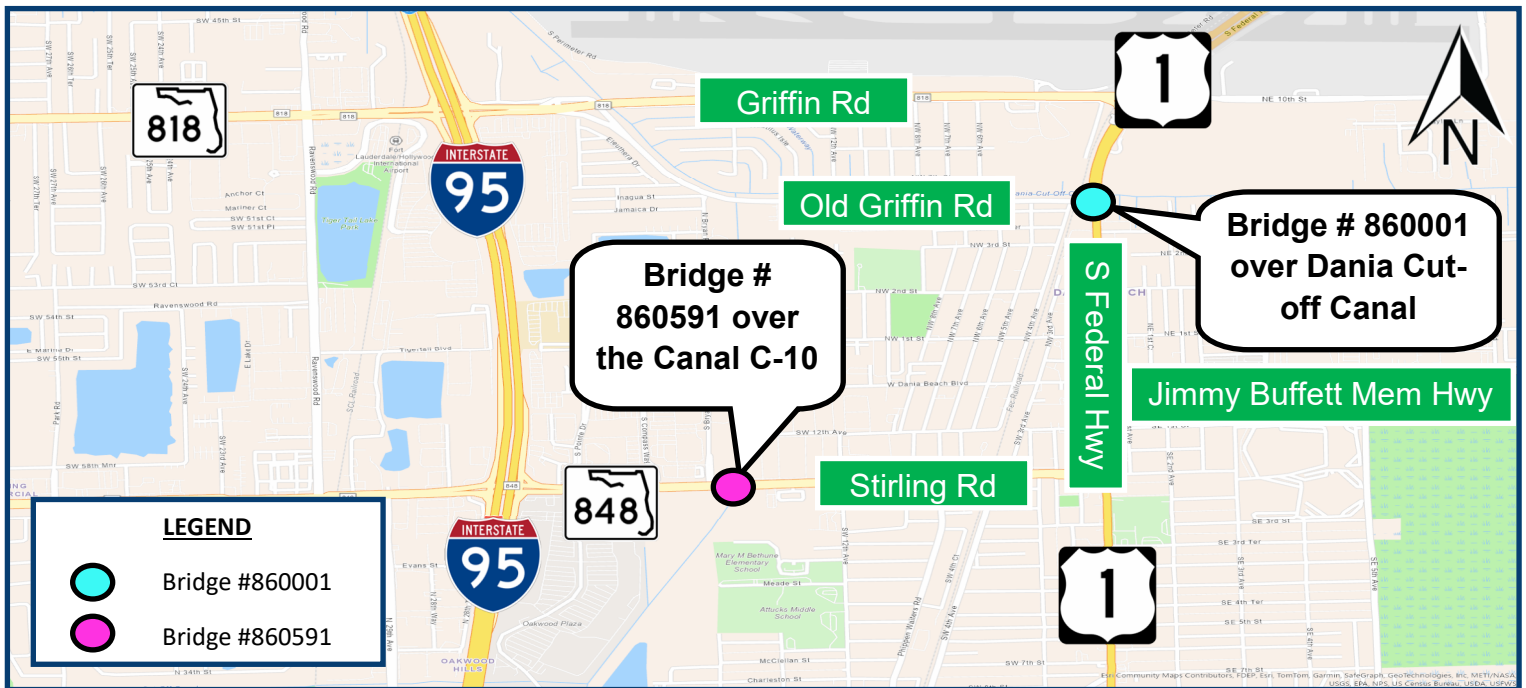
- At least one through lane will remain open at all times.
- All work will be done in phases to reduce the impacts of construction on the community.
- Pedestrian traffic will be maintained at all times.
- Access to businesses and residences will be maintained at all times.
- Passenger access to and from bus stops will be maintained during construction.

### CONSTRUCTION INFORMATION

- Anticipated Construction Start: Winter 2026
- Anticipated Construction End: Winter 2027
- Estimated Construction Cost: \$2.4 Million
