The project limits are on SR 820/Hollywood Boulevard from SR 5/US 1 to SR A1A/North Ocean Drive in the City of Hollywood. This project aims to enhance the safety, resiliency, and longevity of the infrastructure for our communities.

Construction Cost: \$6,226,524 Construction Start: August 2024 Estimated Completion: Summer 2025

PROJECT IMPROVEMENTS

- Milling and resurfacing the roadway along the project limits to enhance resiliency and safety
- Reconstructing the sidewalk along the project limits
- Upgrading technology including pedestrian signals at the intersection of SR 820/Hollywood Boulevard and 13th Avenue
- Upgrading existing lighting to LED fixtures along the project limits to enhance visibility and nighttime safety
