The Florida Department of Transportation (FDOT), District Four, will conduct a Public Meeting regarding the proposed improvements for the above referenced project. This Public Meeting will be offered in two different formats: virtual and in-person. The Public Meeting will have representatives available to answer questions. PROPOSED IMPROVEMENTS

- Modify the existing median opening at the intersection of SR 5/US-1 and Imperial Point Access Road to a bi-directional opening, to restrict left turn movements from the side streets onto SR 5/US-1
- Construct a new traffic and pedestrian signal system to facilitate controlled pedestrian crossings north and south of SR 5/US-1
- Relocate a bus shelter
- Construct pedestrian curb ramps and crosswalks to accommodate pedestrians

CONSTRUCTION IMPACTS

- Temporary lane closures will be needed during off-peak hours
- Access to adjacent properties will be maintained at all times

CONSTRUCTION INFORMATION

- Construction Start Date: **Spring 2022**
- Anticipated Completion: **Winter 2022**
- Construction Cost Estimate: **\$250,000**

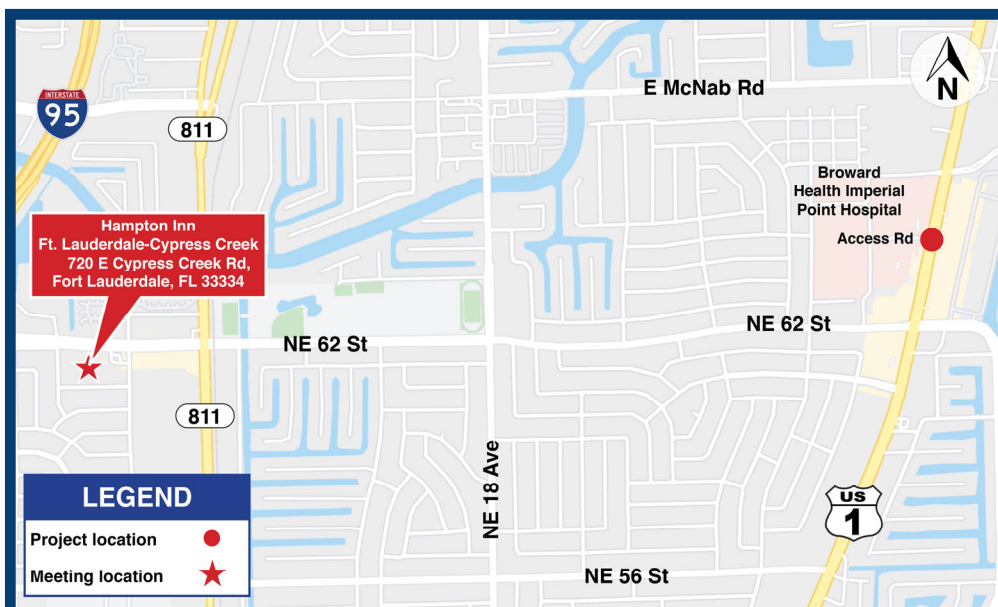
