SR 5/US 1 Earman River Bridge Replacement Project

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming SR 5/US 1 Earman River Bridge Replacement Project in the Village of North Palm Beach. This project aims to enhance the technology, safety, resiliency, and longevity of the infrastructure in our communities. Please see below for detailed meeting information.

Construction Cost: \$13.7 Million **Construction Start:** February 2025 **Estimated Completion:** Summer 2027

PROJECT IMPROVEMENTS

- Replacing the SR 5/US 1 bridge over Earman River to improve safety, traffic flow, and long-term resiliency of the structure
- Widening the roadway to add a second right-turn lane from southbound SR 5/US 1 onto westbound Northlake Boulevard to improve infrastructure resiliency, traffic flow and safety
- Milling and resurfacing the roadway along SR 5/US 1 within the project limits to enhance safety, ride quality and longevity of the infrastructure
- Adding 4-foot and 5-foot bicycle lanes along SR 5/US 1 within the project limits to improve safety for all roadway users
- Upgrading drainage, signage, lighting, signalization, pedestrian curb ramps, and pavement markings throughout the project limits to enhance infrastructure resiliency, traffic flow, transportation efficiency and safety
- Upgrading the Intelligent Transportation System (ITS) to enhance transportation efficiency and safety
- Installing benches and planters throughout the project limits for the Village of North Palm Beach to enhance public spaces

TRAFFIC IMPACTS

- Construction will occur in phases to minimize impacts to the public
- Lane closures are permitted daily from 9:30 a.m. until 5:00 p.m. and nightly from 6:30 p.m. until 8:30 a.m.
- Pile driving activities are permitted from 8:30 a.m. until 5:00 p.m.
- Access to businesses and residences will be maintained at all times
- Pedestrian and cyclist access will be maintained at all times via detours based on construction phasing
