PROJECT PURPOSE

To provide landscaping features along S.R. 804/Boynton Beach Boulevard from NW 3rd Street to U.S. 1/Federal Highway in Boynton Beach.

SCOPE OF WORK

- Provide new landscaping within the median and along sidewalks along S.R. 804/Boynton Beach Boulevard
- Install irrigation system

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce inconvenience to the community
- Short-term single lane closures may be required on S.R. 804/Boynton Beach Boulevard to protect the workers
- Driveway, business, and pedestrian access will be maintained
- Vehicular detours are not anticipated
