## S.R. 15/East Main Street Resurfacing Project

The Florida Department of Transportation (FDOT) invites the community to a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming S.R. 15/East Main Street RRR Project in Palm Beach County. The project limits are on S.R. 15/East Main Street from Annona Street to south of S.R. 700/Conners Highway. This project aims to improve the safety, resiliency, and longevity of the infrastructure for our communities. Please see below for detailed meeting information.

Construction Cost: \$3.5 Million Construction Start: November 2025 Anticipated Completion: Summer 2026

### **PROJECT IMPROVEMENTS**

- Milling and repaying the existing roadway within the project limits to ensure long-term infrastructure resilience and safety.
- Constructing five concrete bus pads throughout the project corridor to enhance transit rider safety and accessibility.
- Installing curb ramps and replacing sections of sidewalk to enhance pedestrian safety and connectivity.
- Upgrading signage and pavement markings, including bicycle lane markings, to enhance visibility and safety.

### **TRAFFIC IMPACTS**

- Work will occur in phases to minimize impacts to the public.
- Single-lane closures will be permitted daily, with flaggers in place to direct traffic as needed.
- Access to businesses and residences will be maintained at all times.


