SR A1A/S. COUNTY ROAD NORTHBOUND DETOUR TO BEGIN MONDAY, JUNE 23, 2025

Beginning Monday, June 23, 2025, the northbound lane and sidewalk on SR A1A/S. County Road at the intersection of S. Ocean Boulevard (just north of Clarendon Avenue), to just south of Banyan Road, in the Town of Palm Beach, will be closed around-the-clock for sidewalk replacement and construction activities through approximately July 2025.

Side streets within the work zone will remain open, with eastbound and westbound movements permitted on Via Vizcaya, Via Del Mar, and Via La Selva for local traffic. A flagging operation may be utilized on side streets as needed.

Traffic will be directed as follows:

- All motorists traveling northbound on S. Ocean Boulevard will not be permitted to turn left/westbound onto SR A1A/S. County Road during this time
- Local traffic traveling northbound on S. Ocean Boulevard will be detoured to westbound Banyan Road to access SR A1A/S. County Road and side streets
- S. Ocean Boulevard, north of Banyan Road, will also remain open for motorists to access existing marked east-west access points to SR A1A/S. County Road
- Sidewalk and pedestrian access will not be available from the intersection of SR A1A/S. County Road to south of Banyan Road during this time
- Southbound SR A1A/S. County Road will remain open throughout the work zone

- Please use caution and drive safely through the work zone as project crews are on-site this summer
- Areas closed off by barricades and signage should only be accessed by project team members
- Please follow the directional signage throughout the work zone and when flagging operations are underway
