The Florida Department of Transportation (FDOT), District Four, will conduct a Virtual Public Meeting regarding the improvements for SR 25/US 27. This Virtual Public Meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting through the registration link or by e-mailing the project manager.

PROPOSED IMPROVEMENTS

- Resurface pavement and realign sidewalks
- Upgrade curb ramps to meet Americans with Disabilities Act (ADA) standards
- Add pedestrian gates at the FEC Railroad crossing
- Upgrade bus stops with landing pads
- Replace signal at SR 80/East Palm Beach Road
- Upgrade drainage, signage and pavement markings
- Upgrade pedestrian signals, intersection lighting, pavement markings, and signing to latest standards

MAINTENANCE OF TRAFFIC

- During construction, single lane closures will be used to construct, roadway widening, drainage improvements, sidewalk, and signal replacement activities
- No vehicular detours or full road/intersection closures
- Temporary impacts to pedestrian traffic will be addressed via temporary pedestrian detours/diversions as required


