


Technical Information for Dial-in Attendees









Project Overview and Speakers

Project Overview:

This project proposes to widen eastbound SR 80 to extend the ramp queue length, mill and resurface the inside lane of SR 80 and the existing ramp, reconfigure the ramp gore to provide a 2 lane ramp entrance, and widen the one lane section of the ramp to provide a dual lane exit ramp.

Additional improvements include adding about 500 feet of MSE retaining wall to allow widening along the ramp, upgrading the existing lighting to LED, and implementing a Wrong Way Driving System at the ramp connection to Australian Avenue.







Existing Typical Section





Proposed Traffic Control Typical Sections (Phase I & Phase II)





