



Scope/Proposed Improvements



- Repave and restripe the existing roadway within the project limits
- Replace sidewalk to meet Americans with Disability Act (ADA) standards
- Upgrade pedestrian signalization and lighting at crosswalks
- Replace traffic detector loops and install traffic signal backplates
- Replace damaged drainage inlet tops
- Upgrade signage and Traffic Monitoring Site equipment
- Install Wrong Way Driving (WWD) Alert system








Special Emphasis Crosswalk/Upgraded Pedestrian Signal





Wrong Way Driving (WWD) Alert System






Construction Impacts



Construction Impacts

- Work will be performed in phases to reduce the effects of construction on the community
- Detours and temporary lane closures will occur during non-peak hours (8:30 p.m. to 6:30 a.m.) reducing impact to the traveling public
- Access to businesses and residences will be maintained throughout construction
- Detours are necessary for ramp Wrong Way Driver installation and repaving (weekends only— four nights total)
- Lane closures will be limited to one travel lane at a time

Estimated Construction Cost: \$2.3 million




