State Road (SR) 729/State Market Road Resurfacing, Restoration, and Rehabilitation Project

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-Person Construction Open House regarding the upcoming State Road (SR) 729/State Market Road Resurfacing, Restoration and Rehabilitation Project in the city of Pahokee. Please see below for detailed meeting information.

Construction Cost: \$ 4.9 million

Construction Start: April 2024

Estimated Completion: Spring 2025

PROJECT IMPROVEMENTS

- Mill and resurface SR 729/State Market Road.
- Widen traffic lanes from 11 feet to 12 feet.
- Widen the existing paved shoulders where feasible within FDOT right-of-way.
- Reconstruct northbound SR 729/State Market Road sidewalks and shared use paths from north of Rock Pit Road to SR 15/US 441/E. Main Street.
- Upgrade signage and pavement markings throughout project limits.

TRAFFIC IMPACTS

- Full road closures will occur in two segments. Only one segment can be closed at a time, and access for local traffic will be maintained throughout the closures. Advanced notice of detours will be provided.

From SR 717/Muck City Road to Larrimore Road

During harvest off-season between May 1st and October 31st, full roadway closures will be implemented around-the-clock, Monday through Sunday.

From Larrimore Road to SR 15/US 441/E. Main Street

Full roadway closures will be implemented around-the-clock, Monday through Sunday, once work is substantially complete on the southern segment.

- One lane and shoulder may be closed from 7:30 p.m. to 7:30 a.m., Monday through Sunday throughout the year.
- During harvest off-season between May 1st and October 31st, one lane and shoulder may be closed from 8:30 a.m. to 4:00 p.m., Monday through Sunday.
- Access to and from all bus stops will be maintained. If access cannot be maintained, a temporary bus stop will be provided no more than 500 feet away.
- Driveway, business, and pedestrian access will be maintained at all times.
