The Florida Department of Transportation (FDOT), District Four, will conduct a Public Information Meeting regarding the above referenced project. Participants may attend in person or online. PROPOSED IMPROVEMENTS

- Repave the existing travel lanes.
- Widen roadway shoulders to 12 ft (7 ft paved).
- Construct sidewalk from North of 3rd Street to Ammons Road.
- Install roadway lighting from North of 3rd Street to Ammons Road.
- Install new pavement markings.

CONSTRUCTION IMPACTS

- Temporary lane closures during non-peak hours will occur.
- All work will be done in phases to reduce the impact of construction to the community.
- There will be no complete road closures.
- Access to adjacent properties will be maintained at all times.

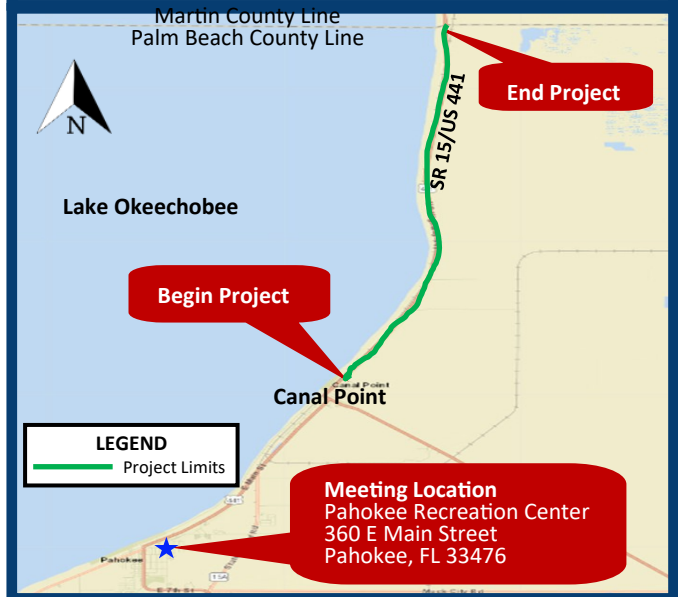
