SR 715 and SR 80 Resurfacing Project

The Florida Department of Transportation (FDOT) will host a Virtual Public Meeting and In-person Construction Open House regarding upcoming improvements along SR 715 and SR 80 within the cities of South Bay and Belle Glade. Please see below for detailed meeting information.

Construction Cost: \$12 Million

Construction Start: July 2023

Estimated Completion: Summer 2025

PROJECT IMPROVEMENTS

- Milling and resurfacing the existing roadway and minor widening of existing paved shoulders
- Installing pedestrian signalization and markings
- Improving signing and pavement markings
- Upgrading pedestrian curb ramps to meet Americans with Disabilities Act (ADA) standards
- Adding new sidewalk on the west side of SR 715 and select locations on SR 80

TRAFFIC IMPACTS

- Construction will occur in phases to minimize impacts to the public
- Lane closures are permitted nightly from 7 p.m. until 7 a.m.
- During harvest off-season, May 1 through Sept. 30, lane closures are permitted daily from 8:30 a.m. until 4:30 p.m.
- Coordination with Palm Tran to mitigate impacts to existing bus stops will occur
- Pedestrian, driveway and business access will be maintained at all times
