PROPOSED IMPROVEMENTS

- Resurface roadway pavement
- Minor widening to accommodate bicycles on the roadway shoulders
- Improve drainage in swales
- Upgrade signing and pavement markings to current standards

CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the effects of construction on the community
- Construction personnel will direct traffic during single lane closures to maintain two-way traffic
- Pedestrian and vehicular access to all properties will be maintained at all times

- Anticipated Completion: **Summer 2025**
- Construction Cost Estimate: **\$8.8 Million**

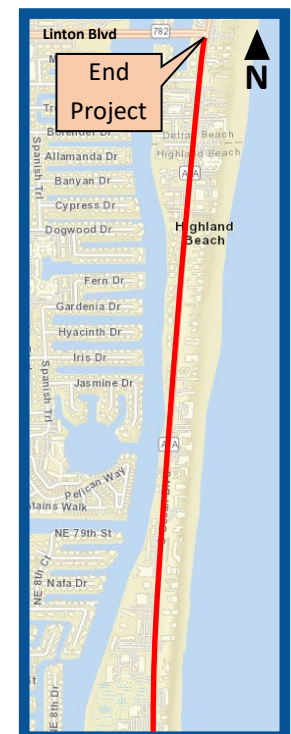
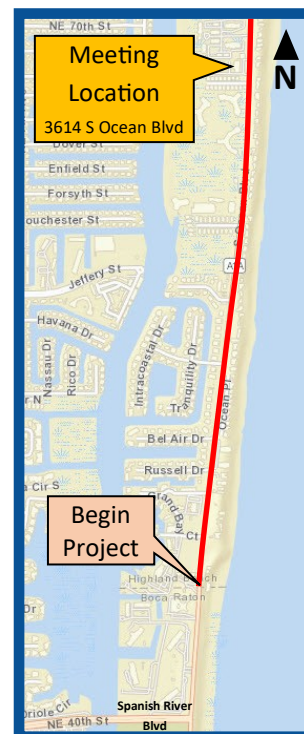
